TENDER NOTICE

On behalf of the BSNL, the General Manager Telecom Hubli-29 invites the **sealed Limited Tenders** from reputed manufacturers or their authorised dealers only for supply of **LINEMAN TOOL BAGS** under the jurisdiction of GMT Hubli, as and when required in a year. The rate should be quoted inclusive of all taxes, transportation and any other charges subject to inspection regarding quality. The specification of the items is given in the point 18 of terms and conditions of tender document.

The tender shall be submitted in the prescribed tender form that may be obtained from the SDE(Tender) o/o GMT Hubli with a request letter addressed to the AGM(Plg) O/O GMT Sanchar sadan, Near railway station Hubli-20. Tender forms shall be issued to only eligible persons/ firms having clear letters stating that they are manufacturers or their authorised dealers on payment of Rs 563/- (Rs.500+ 63 ST) (Non refundable) in cash at the cash counter / DD drawn on any Nationalised Bank in favour of Sr.A.O.(Cash) BSNL I floor CTO Building Hubli.

Procedure for preparing Bid:- The Tender document submitted contain the following documents

- 1.-Bid security as per clause (1) under Deposites
- 2.-Documents to claim that the tenderer is reputed manufacturer or the authorised dealer of reputed manufacturer.
- 3.-Tender document duly signed by the tenderer on all the pages with rubber stamp.
- 4.Rates duly quoted by the tenderer in the prescribed format. (Annexure-I)

The envelope should be properly sealed with sealing wax / Packing PVC tape. The tenders which are not submitted in above mentioned manner shall be rejected on the spot.

The outer envelop should be superscribed as “ TENDER FOR SUPPLY OF LINEMAN TOOL BAGS”.The tender documents other than in the prescribed format issued by this office will not be considered while opening of tender.

Sealed tender as mentioned above should reach this office by Registered post or speed post on or before 1500 hrs of **28.12.2006**. The tenders will be opened in the presence of those tenderers who may choose to be present at 1530 Hrs on the same day.

TERMS AND CONDITIONS

- 1 Any provisional clause included in the quotation as for instance ‘subject to percentage’ ‘Market fluctuations “ etc.. which might effect the price of the article will result I in the tender being rejected.
2. Each tender should pay a sum of RS/- 1200/- towards Earnest Money Deposit in cash counter of GMT ,Pinto Road,Hubli-20 or in the form of D.D. in favour of Sr.A.O.(Cash) o/o GMT Hubli and attach the receipt /DD to the Tender. The tender received without EMD / DD receipt will be rejected. The EMD of the un successful tenderers will be refunded after finalisation of the tender.

Signature of tenderer

3. The EMD while in the custody of the BSNL will not carry any interest. The EMD of the successful tenderer will be retained as security deposit till the completion of supply of the items/completion of the tender validity period. The successful tenderers who are exempted from furnishing EMD should deposit Rs as Additional Security Deposit either in the term of cash or Bank Guarantee from any Nationalised Bank in addition to EMD which has been converted into SD. The security deposit will not carry any interest while in the custody of the BSNL.
4. **The validity period of this tender is upto 30.3.2007**
5. Tender not conforming to the above conditions will be rejected.
6. The GMT Hubli is not bound to accept the lowest Tender.
7. The GMT Dharwad TD Hubli reserves the right to reject any or all tenders without assigning any reasons and the decision of the General Manager Telecom, shall be final and is binding on all concerned and the GMT Hubli also reserves the right to order quantity in full or partial as per the requirement. The tenders are valid for a period of one year with effect from the date of approval of the tender.
8. The GMT ,Dharwad TD Hubli shall also reserve the right to approve more than one tenderer in respect of same or different items listed in the tender.
9. The successful tenderer should be in a position to supply the items under the jurisdiction of the GMT Dharwad Telecom Dist,Hubli. The supply of the items will be within 30 days from the date of the date of supply order by the unit officer under SSA Hubli. If he fails to supply the items within the stipulated time or as per specification, the tender will be cancelled and the EMD/SD paid will be forfeited in favour of BSNL.
10. The GMT Hubli reserves the right to accept or reject any of the tenders and the decision of the GMT Hubli will be final and binding on all the tenderers in respect of all the disputes relating to this tender. No appeal against the decision of the GMT shall be entertained.
11. The supplier shall not sublet the supply contract and no General Power of Attorney to supply the items to any agency/ person to issue the bills/ receive the payment, of any kind will not be entertained.
12. If the successful tenderer is found to be supplying items of poor quality or fails to comply with the specification of the tender, the tenderer is liable to be black listed and will not be allowed to participate in future tenders..
13. The successful tenderer will have to execute an agreement of contract on a stamp paper of Rs.100/- in the Performa supplied by the BSNL.
14. The bills have to be submitted in triplicate to the consignee and payment will be made by cheque within a month.
15. The tenderer should fill up the rates in the enclosed Annexure in figures and as well as in words also. The rate quoted should be all inclusive viz..VAT Freight, handling and transportation etc..
16. Any dispute arising out of this contract is subject to jurisdiction of Hubli Dharwad Municipal Corporation Area Limit.
17. The quantity mentioned is only average and it may vary if required
18. **SPECIFICATION:** The Lineman Tool Bag to be supplied of Size 16” canvas type with BSNL Logo .
19. The Quantity to be supplied is 281 Numbers at present. The number may vary according to the requirements.
