- I. Tender should be sealed and superscripted on top as "TENDER FOR SUPPLY OF XEROX MACHINE under bye-back scheme and addressed by name to Sri H.M.Deokar D E Telecom (A&P) o/o TDM Raichur. The tender should reach the under signed on or before 15.00Hrs of 07-11-2007-and will be opened on his behalf in the presence of the tenderers may wish to be present.
- II. The tenderer should deposit an amount of Rs 5000/-only towards E M D at the cash counter of the office of the TELECOM DISTRICT MANAGER Raichur. And the receipt should be enclosed to the tender. The E M D will be accepted between 10.00 hours to 12.00 hours on all working days up to 07-11-2007. The E M D can also be paid in the form of crossed demand draft drawn on any local nationalized bank in favor of BSNL RAICHUR. The certificate of Registration of the Firm and the latest Income Tax clearance certificate should be enclosed.
- II) (a) Cost of Tender Fee is Rs 563/- payable in cash and forms can be obtained from SDE (Genl) up to 12.00 hrs on 07-11-2007.
- b) payment of EMD is exempted for the following categories tenderer .
- (i) Firms Registered with DG S&D for the supply of stores.
- (ii) Small scale industrial units which are listed with national small scale industries corporation and in effect treated as automatically registered with DG S&D under the revised scheme or the single point registration.

(iii) Public sector under taking which are registered with the Department of DG S&D. Photostat copies of necessary certificates issued by the concerned Authorities and which shall be current shall be current should accompany the tender for claiming exemption.

III In case if the tender documents are downloaded from Internet website. www.karnataka.bsnl.co.in , then the tenderer has to pay tender fee of Rs 563/- in the form of DD drawn from any Nationalized Bank in favor of A O (cash) o/o TDM BSNL Raichur., payable at Raichur and should be submitted along with the tender documents . VI. The BSNL expects the supply of Xerox machines should be fault free and under by back scheme.

VII. The rates should be quoted for Xerox Machines and it should be quoted both in figures and in words .Rates should be inclusive of all taxes ,transportation ,installation configuration etc.. charges.

VIII. The successful tenderer should supply and install the items fault free the items with in 30 days from the date of receipt of supply order and the item so supplied should have minimum warranty period of one year.

IX. If supply of XEROX machine is delayed beyond 30 days a penalty of 5% of the cost will be charged and deduction from the bill/SD.

IX(a) The EMD of the successful tenderer will be retained as Security Deposit(without carrying any interest)during the currency of the contract period and any violation of the tender terms and conditions will result in forfeiture of the EMD/SD.

X. The EMD of the un-successful tenderers will be refunded after finalization of the tender .

XI. The Telecom District Manager ,Raichur reserves the right to reject any or all the tenders without assigning whatsoever and his decision will be final and binding in this regard .

XII. PAYMENTS:--

a)90% payment will be made on each purchase order only after complete installation of the item.

b) 10% of the purchase order will be paid only after submission of installation of item or otherwise it will be kept in the custody of the department till the expiry of warranty period from the date of installation.

c) The purchaser order will be placed depending on the requirement of BSNL in a phased manner.
